- Acknowledgment of all financial contributions to the work being reported, including contributions “in kind.” All funding sources will be listed in the published manuscript. Please indicate on the following statement all funding sources for this study that are not listed on the title page of the paper.
- The following separate statement disclosing to the Editor all financial holdings, professional affiliations, advisory positions, board memberships, patent holdings and the like that might bear a relationship to the subject matter of the contribution.
